
## Building Sector Skills & Understanding

### INTRODUCTION

The Australian Muslim Women's Centre for Human Rights (AMWCHR) is an organisation of Muslim women working to advance the rights and status of Muslim women in Australia.

The Australian Muslim community is characterised by diversity, rather than a binding version of Islam and what it means to be Muslim. Our organisation is committed to reflecting the sectarian, cultural and linguistic diversity within the Muslim community.

AMWCHR's training is based on more than 30 years of service provision to the Muslim community across Australia. Through our training we aim to share our knowledge, expertise, skills and insights to assist organisations, large or small, private, community-based or government, to develop their competence in responding to and working with Muslim communities.

For many years our organisation has provided training at the intersection of culture, faith, race, and gender. We do not only seek to inform but to stimulate discussion and broaden perspectives while reflecting the rich and dynamic areas in which we work.

Our training sessions highlight the diversity of Muslim communities in Australia and emphasise the importance of recognising the complexity and multiple factors that interact to create unique individual and community needs. AMWCHR combines the importance of understanding cultural practices and traditions while recognising individual experiences.

We have developed a reputation for providing the best possible and up to date information and training in knowledge areas that are often contested or represented by multiple agendas within communities or society more broadly. All our training is based on the organisation's extensive research that is regularly updated. ### **Training Sessions:**

### Insights into working with Muslim migrant communities

#### Available as half day or full day workshop

This session introduces a general overview on Islam and Muslim Communities in Australia, which includes an explanation on the Five Pillars of Islam, Islamic values, Festivals and Customs and Muslims in Australia.

The training will also explore the varying migration journeys and settlement experiences in Australia and is designed to support participants to increase their knowledge and understanding of Muslim communities and develop an awareness of the unique challenges and barriers impacting Muslim women, children, and families.

### Responding to Family Violence in Muslim communities

#### Available as half day or full day workshop

This training incorporates universal and culturally/religiously specific information on family violence, focusing on its impact within Muslim communities to highlight the additional challenges that exist and the diverse circumstances that Muslim women experience when dealing with family violence.

The aim of this training is to assist service providers, policy and decision makers to take into consideration the cultural, religious and social factors that impact on Muslim women's lives and deeply influence their response to family violence. This training incorporates universal and culturally/religiously specific information on family violence, focusing on its impact within Muslim communities to highlight the additional challenges that exist and the diverse circumstances that Muslim women experience when dealing with family violence.

### Recognising and Responding to Early and Forced Marriage in Muslim communities

#### Half day workshop

This training provides participants with information on current legislation criminalising early and forced marriages and delves into the origins, drivers and narratives associated with the practice. Exploring Why it's happening? Where? And what is being done here in Australia and elsewhere to ensure no one (men or women, girls or boys) are forced to marry.

What is the impact on the victims, what are the hurdles they face? The training also explores the double-bind of disclosing or not disclosing forced marriage practices?

Service providers, especially schoolteachers, social workers and youth workers who work with Muslim communities may face this issue and require the appropriate tools and knowledge, as well as the community connections and support, to respond appropriately.
